Motion by Supervisor Ferguson, second by Supervisor Starr to hire Charity Butz to fill the newly created School Resource Officer Position, effective June 2, 2014 at a starting rate of \$22.54 per hour plus benefits per the Allegheny Township Police Collective Bargaining Agreement, pending receipt of Act 34, 114 and 151 Clearances. Motion by Supervisor Ferguson, second by Supervisor Starr to approve advertisement of Ordinance #02-2014 authorizing Allegheny Township to create an Intergovernmental Cooperation Agreement with Oklahoma Borough to provide code enforcement services. Motion passed
